### **Announcement: Moody's: No rating impact on notes issued by CIF Euromortgage following amendments**

London, 15 February 2017 -- Moody's announced today that the proposed amendments to both the transaction documents and the cover pool of CIF Euromortgage (the "Issuer") would not, in and of themselves and at this time, result in a reduction or withdrawal of the current Aa2 ratings of the notes issued by the Issuer.

The main amendments include (i) replacement of securitization notes by mortgage loans in the cover pool; and (ii) the use of a collateralised loan structure.

Moody's analysis has taken into account the increased collateral and market risks and corresponding increased over-collateralisation required as a result if the changes were implemented as proposed.

Moody's has determined that the amendments, in and of themselves and at this time, will not result in the downgrade or withdrawal of the current Aa2 ratings of the notes issued by the Issuer. However, Moody's opinion addresses only the credit impact associated with the proposed amendments, and Moody's is not expressing any opinion as to whether the amendment has, or could have, other non-credit related effects that may have a detrimental impact on the interests of note holders and/or counterparties.
